DAVID L. MCCRACKEN, P.E.

SUMMARY

Mr. McCracken is a Registered Professional Engineer in California with 45 years of experience in the heavy construction industry. Since 1964, he has held engineering and management responsibility for many highway and freeway projects as well as several major canal and irrigation projects and airport runway construction. In addition, he has had considerable experience in assisting contractors in the preparation and negotiation of claims.

EXPERIENCE

1960 - 1964

After graduation from the University of Maine in 1959 and a six-month tour of duty in the U.S. Army, his early professional experience included right of way engineering, survey party chief and hydraulic and structural design for the State of California, Department of Water Resources on the California Aqueduct System.

1964 - 1976

At this time, Mr. McCracken entered the construction industry in the area of highway and freeway construction with **Guy F. Atkinson Co.**, South San Francisco, California where he advanced to the position of project manager in 1968. He was involved in the construction of more than \$50 million in then current dollars throughout California. The projects ranged in scope from major excavation projects to a 25-mile long grading and concrete paving project to a four level freeway to freeway interchange. Subsequently, with the joint venture of **C. M. Syar and Pacific Construction Corp.**, Vallejo, CA., he spent the period from 1973 to 1976 as Project Manager/ Area Superintendent managing several concurrent freeway projects as well as significant site development projects including the Anheuser Busch Brewery in Fairfield, CA.

1976 - 1987

During this period, Mr. McCracken was employed by the firm of **Ball, Ball and Brosamer, Inc.**, Danville, CA. His responsibilities within the firm ranged from Project Manager, Senior Estimator, to Project Sponsor (Operations Manager) for a firm specializing mass excavation, concrete slip form paving for canals, highways and airports along with associated heavy concrete structure work. During the period, the company completed a very significant portion of the more than \$1.0 billion Central Arizona Project canal system. During the last two and a half years with the firm, Mr. McCracken covered the seven western states as Project Sponsor on a large portion of the company's projects.

1987 - 1991

Mr. McCracken then assumed the position of Vice President, Heavy Highway for **Ghilotti Brothers Inc.**, San Rafael, California. During this period, he was responsible for over \$100 million in active contracts at any one time, including both public and private projects. He was responsible for selection of projects to bid, bid reviews, equipment selection, overview of project operations, cost control and preparation and negotiations of construction claims.

1991 -1994

During this period, McCracken Construction Consulting provided professional construction management and claims preparation and negotiation for a wide range of contractors.

1994 - 1998

Subsequently, Mr. McCracken assumed the position of President and CEO of **Sully Miller Construction Company**, Anaheim, California, a wholly owned subsidiary of Hanson, plc, London, U.K. While in this position he was responsible for redefining and developing the objectives for the company. He was also responsible for the integration of a newly acquired construction company into the organization. He was instrumental in recruiting and developing a management staff as well as field supervision capable of maintaining profitability while increasing sales of the company by more than two and a half times to \$110 million. Finally, Mr. McCracken coordinated the presentation and sale of the company in 1998 by Hanson, plc.

1999 - Present

Self employed as construction consultant specializing in construction management and disputes resolution throughout the United States. Much of this work consists of working with public agencies and their design engineers during the planning and design process on program cost and risk evaluation. He has also assisted in the preparation and review of construction estimates for several large design build transportation projects. Since 2000, he has served as a member of thirty-four Disputes Review Boards, including seven as chairman. He is currently serving on an Expert Review Panel appointed by the Governor of Washington to evaluate the Washington DOT assumptions for implementation and financing for the \$ 4.5 billion Alaska Way Viaduct project and the \$ 3.5 billion SR 520 Floating Bridge and HOV project.
